**TechLaw Becomes First Contractor to Win 50 Task Orders Under U.S. EPA Superfund Contract; Maintains Status as Top Awardee**

*Company has won more than \$50 million in awards under EPA RAF-ESO Contract Vehicle in 6+ Years*

CHANTILLY, Va. (April 10, 2025) – Two recent task order awards from the U.S. Environmental Protection Agency have given TechLaw 50 such awards under a specialized contract vehicle for small businesses over the last 6 ½ years. The awards extend TechLaw’s position as the single largest awardee under the EPA Remedial Action Framework-Environmental Services and Operations (RAF-ESO) program—both in total task order awards and in dollar value of those awards.

“It’s an amazing achievement, given the amount of competition and the market challenges we have faced,” says TechLaw Chief Operating Officer Patricia Derocher. “It speaks directly to the dedicated environmental and scientific support our people provide, and the trust that EPA puts in us.”

Awards last month of \$552,000 over three years for work in EPA Region 9 in California and of \$177,000 over three years in EPA Region 5 in Minnesota give TechLaw 50 awards valued at up to \$52.4 million for projects that span the country. They include work that has already been completed, as well as several others in progress over the next three years. These most recent awards—for work at the Laboratory for Energy-Related Health Research (LEHR) in Davis, CA, and the South Andover (MN) Superfund Site—will continue to involve TechLaw’s scientific

support of EPA’s remediation of sites with current or anticipated PFAS contamination—a growing part of the company’s expert support at numerous EPA-regulated sites nationwide.

Launched in 2018, the RAF-ESO contract is open to 21 qualified small-business bidders—including TechLaw—to compete nationwide on individual task orders to support EPA Superfund cleanup programs via technical oversight work, including: field work and analytical support, remedy operations (including long-term response actions), and preliminary assessment/site investigation activities. The ESO contract runs through 2028.
